4, 5, & Update on status of draft Management Plan, Consolidated comments on values, threats and Draft community engagement plan objectives and actions were discussed together

SMMP gave an update on the status of the draft Management Plan:

- Thanked members for the significant information and advice they have provided on threats, objectives and actions.
- Nine government agencies have also provided comment on values and threats.
- Now working hard to analyse committee and agency comment and incorporate it into a draft management plan.
- Hope to have that draft management plan to the committee for review as soon as possible.
- There are many issues coming through as common across the five marine parks, but there are also many unique local issues.
- To support a consistent approach across the marine park network where appropriate but also a locally-specific approach where that is appropriate, common issues will be addressed in a single draft network management plan for the five mainland marine parks. Unique issues will be addressed in separate park sections. The committee's feedback on that approach will be appreciated when the draft is available.
- After the committee has had the opportunity to review the draft, it will be submitted to the Ministers for consideration as a draft for community consultation.
- Once the draft has been submitted to the Ministers, the committee's advice will be sought on applying the regulatory actions

 SMMP to email the Draft Engagement Plan to members for feedback and comment on 7 August . from the plan in new management rules including zoning.

Discussion: There was some discussion by the Committee where the following points were made —

- Just because an activity may be identified as a threat it didn't mean that it would be prohibited — increased regulation may not be the answer.
- Increasing urban development and its impact on water quality is a common impact across all marine parks.
- CBMP is the only marine park to have experienced shark attacks in recent years and therefore attracted the most attention of the projects under the Shark Management Strategy.

Draft community engagement plan

SMMP discussed the draft community engagement plan:

- Thanked members for advice on community engagement tools and local stakeholders in response to the paper tabled at the June meeting.
- That comment has now been incorporated into a draft engagement plan.
- The committee's advice on the draft engagement plan would be appreciated.
- Hope to commence a minimum of two months community consultation on the draft management plan.
- Nine government agencies with an interest in marine park management and members of the Marine Estate Expert Knowledge Panel are also currently reviewing this draft engagement plan.

7. Update on projects being undertaken in the Richmond River catchment under the Marine Estate Management Strategy

Marine estate agency staff provided presentations on the following topics —

- DPI Fisheries projects relevant to CBMP including — conducting workshops and education programs to improve water quality and reduce litter; working with agencies to develop guidelines to incorporate fish friendly features in breakwater maintenance works; collaborating with research institutions on a number of Marine Vegetation Strategy projects; undertaking several on ground wetland rehabilitation projects; developing strategies to manage foreshore structures in the Richmond and Brunswick River estuaries and a Bank Management Strategy in the Brunswick estuary; providing fish passage at a priority weir and road crossing barriers; and working to achieve better alignment of the Key Fish Habitat Offset Policy with Biodiversity Conservation Act offsetting; a number of projects undertaken within the **Emigrant Creek Catchment including:** working principally with the Macadamia Industry on riparian rehabilitation works and Orchard Management Plans to reduce erosion; bank stabilisation works near Teven; sealing dirt roads at 15 locations; and working to improve the management of fertigation (nutrients supplied via irrigation) requirements for blueberry crops.
- DPIE-EES indicated that governance in the Richmond River catchment had long been identified as a hurdle to efficient and coordinated natural resource management and investment at a catchment scale and the Department of Planning, Industry and Environment, in collaboration with the Richmond catchment councils and Rous

County Council, had co-funded a \$12,000 consultancy to review governance and identify recommended governance and funding models. The Richmond River Governance and Funding Project was completed in late 2019 and makes two recommendations for improving governance of the Richmond River catchment. The next year of funding has been allocated for a project officer to continue working to establish a new governance framework, and working to reduce diffuse source water pollution in the Richmond.

8. Other business & next meeting date

a) Marine Estate Management Act review

PLMP addressed the committee regarding the review of the *Marine Estate Management Act* 2014.

- Checked with Advisory Committee
 members that they received an email and
 2-page discussion paper from the Marine
 Park Manager inviting the Committee to
 provide input to the statutory review of the
 Marine Estate Management Act 2014 by
 close of business of 28 August 2020.
- Described requirements for the Act review as set out in section 84 of the Act.
- Provided brief background on the Act and the marine estate and marine park programs that it delivers.
- Outlined that peak stakeholder groups, including the six marine park advisory committees, that would be most familiar with the Act have been contacted to provide input.
- Noted that the discussion paper requested that the Committee provide details of any issues raised with the Act, reasons for those views and suggested solutions.

- Committee members to email comments to MCBMP by 21 August 2020.
- MCBMP to collate comments and forward to the Chair by 21 August 2020.
- The Chair to have collated, and committee approved, the joint response to the Act review be sent to PLMP by 26 August 2020

- Noted that the Act review discussion paper was not for further distribution, but this did not preclude members discussing the Act with their colleagues.
- The presentation was followed by discussion and PLMP responded to questions and requested that CBMPAC prepare a joint submission.
- MCBMP suggested that committee members email their individual comments to him and he will collate and forward to the Chair to prepare the joint response. The Chair will forward to members for approval before submitting to PLMP (Action 20.13).
- b) Peter Watts advised that neither he nor Joshua Hayhoe can provide a spearfishing contact to provide comment from the perspective of spear fishers. This was in response to a request made by PLMO in the previous CBMPAC meetings agenda item developing a plan for community consultation.
- any measuring systems in place to show if the projects being undertaken in the Richmond River under the Marine Estate Management Strategy are making any improvements to water quality? DPI Fisheries staff responded on behalf of the three Richmond River guest speakers that current measures included;
 - Application of a risk-based framework
 - Monitoring done by EES
 - Site based water quality testing in Emigrant Creek.
